

Stopping of Iraqis Refugees Cases by UNHCR is Criminal and Inhuman Act, and Stopping of Iraqis Refugees Cases by UNHCR is Criminal and Inhuman Act, and Should be Ended

Under pretext of down falling of Ba'ath's regime and political situation in Iraq, UNHCR and many of European countries, America and Australia have already campaigned tightly before these events upon Iraqis refugees. They started a wide political and information campaign against Iraqis refugees and they stopped practically the rest of Iraqis refugees affairs. Ten thousands of Iraqis refugees were stopped under waiting and unexampled anxiety by UNHCR's offices and the camps of those countries, and this inhuman policy is still valid. At that time, we declared that these policies and steps are inhuman and irresponsible policies and against to the rights of refugees and transgressed upon the simplest rights of human rights. Also, we declared the down falling of Ba'ath's regime and Saddam by America, it never means that Iraq turns to a calm country, civilization, protector of human rights and a democracy system will be ruled in Iraq; political freedoms and equality between women and men will be achieved. We declared Iraq now was occupied by America and Britain, there is transgression against rights of Iraqis people daily and their wealth is robbed. We said it will not be expected from those nationalists, religious and tribal parties to act for people's interests; but their hands have been reddened with Iraqis people's and each one of them will be a factor to create insecure, terror, killing, unavailability of rights and breaking out of national, civil, tribal and religious war in future... But UNHCR and those countries in order to continue with their anti-refugee policy especially with Iraqis refugees and for their purpose without paying any consideration, they declared Iraq now is a calm country, Iraqis refugees could return to their home country, but after 6 months of down falling of Ba'ath's regime, the events and documents showed opposition of their speech even the facts are so clear for everyone that needn't to offer samples and they themselves claim. In spite of down falling of Ba'ath's regime there are fight, terror, kidnapping, arresting and torture as every day life. The situation steps towards complication that during the last of 20 days as a result of war, explosion of Jordan's Embassy, national problem between Kurds and Turkmen in Tuzkhurmatu and Kirkuk cities, explosion of the main headquarter of UN in Baghdad city, the explosion of Njaf city, assassinating of Bakr Al-Hakim, assassinating of Muhammad Husein one of the head of PUK's security administration in Sulaimania city by Ansar Al-Islam band, shooting and war of U.S.A and Britain forces led to kill 150 persons and 300 wounded of Iraqis people and terrorizing of hundreds of women. The events are in such a way that a religious and civil war and black bloody scene threaten the rest of Iraqis people's souls in a hand; and till now there's no elected government, law, civilization constitution and keeper to people's right in another hand, but the one that available is governing of U.S.A. and authority of those parties, religious and national forces over people. When UN says to Iraqis refugees that Iraq is safe and Ba'ath's regime was down fallen under this pretext he stopped the Iraqis refugees affairs. They want to force them to return them to inside the country of killing and explosions, his headquarter is exploded, his head is killed and thus he is obliged to move his officials and headquarters to the neighbour countries even he transferred his officials from Basrah to Kuwait. Hence, it appears that UNHCR and those countries that have Iraqis refugees how great wrong and criminal were done against Iraqis refugees and how they have transgressed on the refugees rights and the most principles of human rights and they are responsible to remain them under waiting and all tragedies and disasters that happen to Iraqis refugees. Therefore, we as Federation of Iraqi Refugees in Turkey, we condemn the stopping policy of Iraqis cases again under a permanent waiting and ask to end this policy, having reply to the rest of Iraqis refugees, getting them the refugee status and will not be shown irresponsibility and crime against Iraqis refugees by UNHCR any more. Also, we ask all of the refugees, presidentialities, foundations, parties and all of sides who supporting the refugees rights and human rights to hold up the refugees demands, express their dissatisfactions by various ways to be conflict and co-operate with us to end and condemn the anti-refugee policy of UNHCR and those countries.
